2019 Tax Abatements

Pursuant to IC 6-1.1-12.1-8, the County Auditor shall publish not later than December 31st of each year a listing of the real and personal property abatement deductions that were granted in the Economic Revitalization Areas in the County during the current year.

A Tax Abatement is a property tax deduction from the assessed valuation granted by a fiscal governing board for the installation of qualifying abatable equipment/buildings in an ERA, an Economic Revitalization Area. A Tax Abatement can be on both the real property and the personal property of a business depending on the approval of the governing board.

The following are the businesses in Starke County who qualified for and received tax abatements in the payable tax year, 2019. The chart lists the name and address of the business, real or personal property abatement, the number of years of tax abatement they received, which year of the abatement 2019 is in their abatement schedule, and the amount of their abatement.
