An event was created on Facebook, an email blast through the Starke County Chamber of Commerce and the Marshall Chamber of Commerce..

During this period, the station manager continued training to ensure equal employment opportunity and preventing discrimination. The General Manager studied chapters three and four of the book, EEO Law and Personnel by Arthur Gutman.
