On December 7, 2023 Deputies responded to a report of a battery in Medaryville. This led to the arrest of James Mclin for misdemeanor Domestic Battery.

(All parties are innocent until proven guilty in a court of law.)

During the 7-day period, Deputies with Pulaski County Sheriff's Office logged 144 calls for service. Of these calls, 47 of them were traffic stops. The other 97 calls consisted of property damage (only) crashes, suspicious activity calls, 911 hang up calls, trespassing complaints, VIN checks, harassment investigations, an auto theft investigation, responding to a mental health crisis, a missing person call, welfare checks, incorrigible juvenile calls, fraud investigations, alarm calls, and domestic disturbance calls.
