On January 19, 2024 Sheriff's Deputies were called for a welfare check on a juvenile near CR 300 South and CR 700 West, Winamac. This led to the arrest of Marla Nine for Domestic Battery.

On January 20, 2024 Deputies attempted to serve an arrest warrant at a residence in the Town of Winamac. This led to a search warrant for narcotics. Tequia Doty, Steven Neeley, and Bridgette Blankenship were charged with various controlled substance related charges. Charges include Possession of Methamphetamine, Possession of a Narcotic Drugs, and Possession of Marijuana.

On January 21, 2024 Deputies responded to a fight call near the town of Denham. This led to the arrest of Maggie Back for Domestic Battery in the presence of a Juvenile.

On January 23, 2024 Deputies responded to a crash near the area of CR 1300 West and CR 800 South, Francesville. This led to Marla being issued a summons for operating a motor vehicle without ever having a license.

On January 23, 2024 a traffic stop was conducted in Medaryville. This led to the arrest of Travis Joseph for Possession of Methamphetamine.

On January 24, 2024 a traffic stop was conducted in Medaryville. This led to the arrest of Patrick Williams for arrest warrants out of Laporte County.

On January 24, 2024 West Central School Corporation called-in in reference to a juvenile issue. After an investigation by Deputies stemming from the complaint, Nicole Burton was arrested for Invasion of Privacy and Contributing to the Delinquency of a Minor.

On January 25, 2024 a traffic stop near the area of US 35 and CR 250 North, Winamac led to the arrest of Grant Gaines for a misdemeanor driving offense. Grant was issued a summons and released from the scene.

During the 7-day period the Pulaski County Sheriff's Office logged 117 calls for service. Of the calls for service 22 of them were traffic stops. Deputies have also pulled case reports for death investigations, protective order violations, vandalism reports, child molestation investigations, and mental health calls requiring emergency detention.

Pulaski County Corrections is overseeing the care and custody of 98 inmates currently.
