

On February 1, 2024 Deputies were called to a residence in Francesville for a welfare check. This led to the arrest of Joseph Evans for Domestic Battery.

Pulaski County Sheriff's Deputies logged 156 calls for service during the 7-day period. Of the calls for service, 67 of them were traffic stops. Deputies also handled death investigations, fraud reports, thefts, welfare checks, alarm calls, VIN checks, response to medical calls, domestic violence calls, and fight in progress calls.

Pulaski County Dispatch logged the following statistics:
