

On March 03, 2024, a Deputy conducted a traffic stop in Francesville which led to the arrest of Jordan Greenwade for a misdemeanor driving status offense. Jordan was issued a misdemeanor summons to court and released from the scene.

During the 7-day period Sheriff's Deputies logged 148 calls for service. Of those calls, 69 of them were traffic stops. Deputies also handled 1 death investigation. Other responses include theft reports, suspicious vehicle calls, property damage crashes, a semi rollover crash, alarm calls, a school bus stop arm violation, domestic disputes, drug investigations, and welfare checks.

The Pulaski County Jail is overseeing the care and custody of 74 inmates.
